## CONDITIONS

### 1. Copyright

All responsibility for possible copyright infringement and invasion of privacy arising from use of reproductions from the collections of the Notre Dame Archives is assumed by the user. The user agrees to indemnify and hold harmless the University of Notre Dame ("Notre Dame"), its officers, trustees, employees and agents from and against any and all claims, damages or liability (including attorney's fees) that Notre Dame, its officers, trustees, employees and agents may incur as a result of or in any way related to the use or redistribution of the reproduction.

b. Completion of this form, including a counter signature by a representative of the Notre Dame Archives, gives the user Notre Dame's permission to duplicate whatever material was provided by the Notre Dame Archives for which the University holds rights, title, or interest.
