Official announcements

INCREASE IN NOTRE DAME REPORT SUBSCRIPTION RATES: Effective with the first issue of the 1972-73 academic year next September 15, the mail subscription rate for Notre Dame Report will be \$6 an academic year. The publication will continue to circulate free to all faculty, professional staff and students holding positions on official University councils and committees. Individual copies of Notre Dame Report will be available in the University Bookstore for 30 cents. These increases were dictated by a review of the publication's printing costs during its first year of existence.

NOTRE DAME REPORT SUMMER SCHEDULE: The summer schedule of Notre Dame Report has been changed from that announced in issue Number 18, and the Index will now be published in August, not June.

Notre Dame Report No. 19--Published June 30 (Deadline: June 19)

Notre Dame Report No. 20--Published July 28 (Deadline: July 17)

Index for Volume 1 (issues 1 through 20)--Published August 25

The regular fortnightly schedule will resume with the Notre Dame Report of September 15. Note the lengthy period from July 28 to September 15 in which no regular issue of Notre Dame Report will be published.

New accounting system

On July 1, 1972 the University will implement a redesigned and reprogrammed accounting system.

The new system will provide departmental and fund administrators with reports that are similar in format to those provided in the past, but modified where appropriate to provide additional information.

The revised accounting system likewise incorporates an account numbering system that is restructured (see "Documentation"). It is of paramount importance that all administrators be advised of this account number change. When the new system becomes operational on July 1, 1972 all account numbers previously in use at the University will be invalidated.

The Comptroller's Office will communicate new numbers to all budget unit and fund administrators prior to July 1, 1972. Any administrator or principal investigator who has not received such a communication by that date should contact the Comptroller's Office.

The implementation of the revised accounting system necessitates the conversion of large amounts of data from old files to the new computer based files. Because of the volume of data to be converted and the fact that some of the data will not be available for conversion until the University accounting for the fiscal year ending on June 30, 1972 is completed, it will be necessary to suspend printing of the monthly budget unit and fund reports for the month of July. The initial reports under the new system will be prepared at the end of August but will include all accounting activity since the first of July.

New Fringe Benefit and Eligibility

Effective also July 1, 1972 for those participating in the program the University will contribute one-half of the premium cost for Blue Cross-Blue Shield for all Staff Executives, all Staff Managers, and also for those Staff Specialists who have completed 5 years of service at the University.

Deductions

Commencing in June (we deduct a month in advance) eligible participants in the Blue Cross-Blue Shield program will have individual deductions reflecting the new benefit as follows:

Future Eligibility

Professional Administrators not enrolled in Blue Cross-Blue Shield may enroll in the Blue Cross-Blue Shield plan during the regular re-enrollment period in January, 1973 and each January thereafter. Those eligible Administrators (who join in January, 1973) will receive the premium fringe benefit effective July 1, 1973 at the then current level of University contribution.

Professional Administrative Specialists participating in the Blue Cross-Blue Shield program who reach their 5th anniversary of employment will be eligible for the benefit on that date.

Historic Episcopalian consecration

A bishop was consecrated for the Episcopal Church in ceremonies June 24 in Sacred Heart Church.

The historic ceremonies were hailed by Rev. Theodore M. Hesburgh, C.S.C., as "a sign of ecumenical maturity." The use of Sacred Heart for the consecration had the approval of Bishop Leo J. Pursley of the Diocese of Fort Wayne-South Bend.

Rev. William C.R. Sheridan was consecrated fifth bishop of Northern Indiana by Bishop Walter C. Klein, who is retiring as bishop of the Episcopalian diocese. Assisting Bishop Klein as co-consecrators were Bishop James M. Montgomery of Chicago and Bishop Francis C. Rowinski of the Western Diocese of the Polish National Catholic Church, which is in communion with the Episcopal Church.

This was not the first use of a Catholic church for a Protestant consecration, but it had no precedent locally. The first Protestant prayer service in Sacred Heart took place during a United Church of Christ meeting on campus in 1968. Two years before that, a newly formed Methodist congregation used a campus auditorium for Sunday services while they built a church north of the campus. And Episcopalian are no strangers to Notre Dame's campus. In the summer of 1969, a special national convention of the Episcopal Church in the United States was held at Notre Dame.

Tuition increase

The University of Notre Dame has announced a \$150 increase in undergraduate tuition to \$2,450 a year and an increase of \$75 in average room and board fees to \$1,100.

In a letter to the parents of Notre Dame undergraduates, Rev. Theodore M. Hesburgh, C.S.C., University president, said the increase was "necessary to maintain the quality of a Notre Dame education and the calibre of student life here at a time when educational costs and other costs continue to rise."

Father Hesburgh also noted that the increase "would safeguard the fiscal integrity" of the institution at a time of widespread financial stress in higher education.

The tuition for Notre Dame's Graduate School was raised \$185 to \$2,230 a year.

Advance guidance tests

Freshman students planning to attend Notre Dame in September will receive advance guidance tests this summer at regional testing centers across the nation, according to a program developed by Dr. Emil T. Hofman, dean of the Freshman Year of Studies.

Designed to provide the best available academic program and counseling service for the incoming students, the tests will include subject matter achievement tests, academic and career interest tests, and personality tests. A student activity report will be included as part of the program.

Advance testing, rather than orientation week tests in September, will permit counselors to recommend and plan remedial courses or advanced sections as the scores indicate, Hofman said.

Testing centers have been set up in Chicago, Cincinnati, St. Louis, Cleveland, Syracuse, Pittsburgh, Boston, New York City, Philadelphia, Los Angeles, Detroit and Indianapolis. Students may also take the tests at Notre Dame on July 7, 14, 21 and 28, and on September 1.

M.B.A. Commencement

The M.B.A. program in the College of Business Administration graduated its largest number of students -- 67 -- in May. Lawrence J. Ryan, Jr., received the award for outstanding academic achievement, and he and Walter T. Sulkowski received the Dean's Award for outstanding contributions to the program. Selected by the M.B.A. Class of 1972 as outstanding teachers were Associate Profs. Paul F. Conway and Edward R. Trubac of the Department of Finance and Business Economics.

ND-SMC coordinated department

The University of Notre Dame and Saint Mary's College will launch an experimental, cooperative effort between their Departments of Theology and Religious Studies beginning this fall.

Rev. David Burrell, C.S.C., chairman of the Department of Theology at Notre Dame and Dr. Harold Weiss, chairman of the Department of Religious Studies at Saint Mary's, explained that the new effort will be called a "coordinated department" and will not involve "unification" of the departments, nor any transfer of funds.

While maintaining separate chairmen and budgets, the departments will cooperate in hiring and curriculum development. Students at both institutions will have totally free access to all departmental offerings.

Mediaeval Institute photographs

The University of Notre Dame Mediaeval Institute has acquired 1,000 glossy photographs of illuminated liturgical manuscripts in the libraries of Florence, Sienna, Lucca and Prato.

Institute Director Canon Astrik L. Gabriel said some of the photographs are very precious because they are of manuscripts later damaged by the Florence flood of a few years ago.

In addition, the Institute has acquired 1,000 photographic reproductions relating to the iconography of Mediaeval student and University life.

These reproductions will be added to the Institute's Frank M. Folsom Ambrosiana Microfilm and Photographic Collection, which is supported by the Samuel H. Kress Foundation and contains some 15,000 photographs of miniature paintings in Milan's Ambrosiana Library from the Classical, Mediaeval, Renaissance and Baroque periods. All materials are available through interlibrary loan.

Upward Bound

About 80 South Bend area high school students are participating in the University's annual Upward Bound program which began June 18.

For the second year, the Notre Dame classes will be open to both boys and girls from low income families "who are chosen for their potential, not their achievement," according to Archie J. Bradford, director. Girls were enrolled at Saint Mary's College and boys at Notre Dame before last year.

Both Notre Dame and Saint Mary's staff members will direct a program of instruction in history, English

art, mathematics, radio, writing and community outreach projects. Brother James Everett, St. Joseph High School principal, will again serve as chief counselor, and a group of 10 college students, formerly participants in Upward Bound, will serve as tutor-counselors.

Bradford said 24 of 25 high school seniors in last summer's program successfully completed their freshman year at colleges or universities. Two graduates in the May commencement class at Notre Dame previously participated in the Upward Bound program originated at the school in 1966, he added.

Morris Inn open house

The Morris Inn held an open house June 25, marking its 20th anniversary as a hostelry for campus visitors and unveiling the results of the most extensive face-lifting in its history.

Improvements included expansion and new equipment in the kitchen area; expansion and restyling of the public dining room, including a new, adjacent cocktail lounge; remodeling of the main lobby, the corridors and guest rooms, and renovation of the main floor private dining area and the lower-level reception-dining room, which is now known as the Blue and Gold Room.

The Inn was a million dollar benefaction of Ernest M. Morris, a 1906 law graduate who founded in 1917 the firm now known as Associates Corporation of North America. It was completed in 1952.

London Law School summer session

A record number of American law students will be attending summer session classes at the University of Notre Dame Law School at Brunel University, London, according to a preliminary report by Professor Peter W. Thornton, director of the program.

Classes began Monday, June 19, for 108 students from 62 American law schools. A combined British and American faculty are presenting courses in federal jurisdiction, international business transactions, public international law, and other subjects through August 1.

Athletes' academic averages

All but four of the 94 seniors among the University of Notre Dame's varsity athletes were graduated with their class in May, Prof. Michael DeCicco, assistant advisor to Notre Dame athletes has reported.

The four who did not graduate are football players who reduced their academic program while recovering from serious injuries. They will receive their degrees in January, 1973.

DeCicco's own fencing team again led those in nine

other sports in overall average for the spring terms. The 21 fencers averaged 3.090 for the last academic term, compared with an average of 2.826 for all 365 varsity athletes. The average for all athletes was virtually the same as that for the University's 6,200 undergraduates, which is 2.893.

Association of American University Presses, Inc.

"The Impending Crisis in University Press Publishing: A Challenge for the Seventies" was the topic June 23-24 when more than 250 directors and staff

officers from 70 institutions in this nation and abroad met at Notre Dame for the annual meeting of the Association of American University Presses, Inc.

Rising publication costs and reduced purchases by budget-conscious libraries are causing many universities, including Notre Dame, to order feasibility studies of their publishing enterprises with the possibility they will be discontinued in favor of academic operations with a higher priority.

Emily M. Schossberger, a director of the national group and recently retired director of the Notre Dame Press, opened the conference with an official welcome. Rev. James T. Burtchaeil, C.S.C., Provost, extended greetings from the University at a special luncheon.

Miscellany

Dr. John G. Beverly, assistant professor in accounting, will present a paper at the Concurrent Session D., American Accounting Association's 56th Annual Meeting in Salt Lake City on August 22. The title of the paper is "A Portfolio of Trade Credit Risks Employing Ledger-Based Decision Parameters."

Dr. Michael J. Francis, associate professor of government and international studies, was chairman of the panel on "The Impact of Military Aid on Latin America" sponsored May 26-27 by the Center for Policy Study of the University of Chicago.

Canon A.L. Gabriel, director of the Mediaeval Institute, has been invited by the University of Munich to give a lecture July 5 on the international relations of the University of Paris and the University of Ingolstadt. Ingolstadt was the mediaeval predecessor of the present day University of Munich which is observing its 500th anniversary this year.

Prof. Gabriel is also going to address the University of Saarbrücken on the history of the German scholars at the Mediaeval University of Paris. Canon Gabriel also presented an address at the University of Paris.

Dr. Robert G. Hayes, associate professor of chemistry, has been awarded a NATO Senior Postdoctoral to study at Oxford this summer. Dr. Hayes will leave July 1 for a two month stay at Oxford, where he will study with Dr. R.B.J. Williams, a specialist in porphyrins.

Dr. John H. Kennedy, professor of government and international studies and director of the Program of Latin American Studies, has been invited to prepare a section on the Catholic Church in Latin America for the Latin American Encyclopedia to be published by McGraw-Hill next year.

Dr. Kennedy also participated in the conference on Brazil's International Role in the Seventies sponsored by the Foreign Policy Research Institute in New York May 19-20. He presented the statement on Expectations of Other Latin American Nations Regarding Brazil.

David T. Link, associate dean of the Law School, was a speaker in the Economics and Management Conference of the American and Canadian Bar Associations June 2-4 in Toronto.

Dr. Cary K. Mak, associate professor of civil engineering, will present a paper entitled "Monte Carlo Simulation of the Nonlinear Response of Thin Arches with Random Imperfections" at the 1972 Summer Simulation Conference in San Diego, Calif.

"The Pentecostal Movement," a book by Rev. Edward D. O'Connor, C.S.C., associate professor of theology, has been chosen for a Catholic Press Association award in the paperback category. The book describes the growth of the Catholic Pentecostal movement and treats the theology behind it.

Prof. Christopher O. Osakwe, has resigned as assist-

ant professor of the Law School to accept a position on the law faculty at Tulane. He will also spend three summer sessions in post-doctoral study at Harvard. His associates at Notre Dame voted its commendation and appreciation to him.

Dr. Karamjit Rai, professor of biology, will spend six weeks in India this summer as an advisor to a World Health Organization (WHO) program. The team plans to use genetic methods to reduce local infestations of the yellow-fever mosquito.

Dr. David R. Sharpe, assistant professor in the Department of Aerospace and Mechanical Engineering, was invited to present a lecture at Purdue University on "Data Collection and Analysis in the Study of the Criminal Court Systems," on May 24.

Dr. Neil H. Schilmoeller, associate professor in the Department of Aerospace and Mechanical Engineering, has been invited to participate in a panel on "Technological Assessment Role of the Humanist" at the meeting of the American Society of Engineering Education in Lubbock, Tex. June 19-21.

Dr. Thomas G. Smith, assistant professor of chemical engineering, will present a paper entitled, "The Numerical Simulation and Design of a Homogeneous Non-Isothermal Multi-Pass Shell-and-Tube Reactor," at the ASME-AICHE National Heat Transfer Conference in Denver, Colo., August 6-9. Necrology

Rev. Joseph J. Corcoran, C.S.C., a former Notre Dame professor, died suddenly May 19 in South Bend where he was visiting friends while on leave from duties as chaplain at Mercy Hospital, New Orleans.

Fr. Corcoran served as chaplain at Saint Mary's College from 1946 to 1948, as assistant pastor at St. Patrick's Church, South Bend, from 1948 to 1956, and as pastor of the church from 1956 to 1960. After leaving St. Patrick's in 1960, he served for 10 years as assistant pastor of Sacred Heart Church, New Orleans, and the last two years as hospital chaplain.

Social Science Research Council Grants to Minority Scholars for Research on Racism and Other Social Factors in Mental Health

NO. FY72-74

The Social Science Research Council has announced a program of grants to enable scholars from minority groups to undertake research on relations between racism or other social factors and mental health. This program is made possible by a grant to the Council from the Maurice Falk Medical Fund. Research projects may focus upon social structures and processes or on adaptations of the individual. Factors contrib-

uting to mental health and mental illness in the individual and in the society may be examined, as well as all aspects of intervention for prevention, cure, and rehabilitation. Other appropriate topics for research include social organization for treatment of mental illness, or the mental health consequences of social action to resist isolation, estrangement, or oppression.

Eligible to apply are scholars from minority populations, especially American Indians, Blacks, Chicanos, and Puerto Ricans. Applicants should have earned the Ph.D. degree in a social or behavioral science. Special consideration will be given to imaginative research proposals submitted by younger scholars who have the Ph.D. degree and are just beginning research careers.

Awards ranging up to \$10,000 may provide for part-time maintenance in lieu of salary for up to 12 months, and modest amounts for clerical and technical assistance, travel, collection of data, and other research expenses. Requests for renewals will be entertained but will be reviewed in competition with all current applications.

Social and behavioral scientists interested in applying for support are invited to write to the Council describing briefly but explicitly the nature of the proposed research, the data to be used and the method of obtaining and analyzing them, and the significance of the research problem in respect to the field of racism and other social factors in mental health. In addition, the preliminary inquiry should include the applicant's age, occupation or current activity, and academic degrees held. These inquiries should be made as early as possible so that completed applications can be submitted to the Council by October 1. Awards will be announced in December and may be taken up any time in the following calendar year.

Memorandum to Departmental and Fund Administrators from the Comptroller

Memorandum to: Departmental and Fund Administrators

Subject: University Account Numbers

The University will implement a redesigned and reprogrammed accounting system effective July 1, 1972.

This revised accounting system incorporates an account numbering system that is likewise restructured.

The purpose of this memorandum is to furnish you with the new account numbers which must be used beginning July 1, 1972 for budget operations and funds subject to your supervision and control.

The new account number is a fifteen digit number with two component parts -- a budget unit component or a fund component of nine digits and an income or expense type component or six digits. The budget unit component or fund component designates respectively the department or fund affected by a transaction and the income or expense type component designates the specific kind of income or expense being recorded.

Previous University policy required administrators authorizing accounting transactions to designate only the budget unit or fund component of the account number. Commensurate with the implementation of the new system on July 1, 1972 it will be necessary for administrators authorizing accounting transactions to be responsible for furnishing the complete fifteen digit account number to be used in recording the transaction. The purpose of this procedural change is to insure that the person who is most knowledgeable about the fund source and the nature of the transaction classify it for accounting purposes.

The account numbers which you will need are presented on the following attachments, as applicable:

- I. Budget Units and Funds
- II. Types of Expense
 - A. General Purpose Group
 - B. Special Purpose Group
- III. Income Accounts

Attachment I lists the budget units and funds for which you are an administrator according to our records.

Attachments IIA and IIB list the account number components which are used to classify expenditures. Attachment IIB is included only if you are the administrator of a budget unit or fund requiring some special expense category. A narrative is included for certain accounts wherein the purpose might not be apparent from the title alone.

Attachment III lists income accounts and is included if operations subject to your control are of such nature as to require them. For your convenience income accounts are presented as complete fifteen digit numbers.

The account numbers furnished on the enclosed attachments should enable you to code the complete fifteen digit account number for all transactions which you would normally handle as a budget or fund administrator.

For expenditure of funds you select from Attachment I the nine digit budget unit or fund number to be charged and add to that number the six digit number from Attachment IIA or Attachment IIB that correctly describes the type of expense. The administrator, for example, of a budget unit that is assigned the number 1950-00004 would in submitting a requisition to the Purchasing Department to buy supplies, code that requisition with the number 1950-00004-920022.

For income items you simply select the number from those presented on Attachment III which appropriately describes the item.

Undoubtedly there will be instances of our having failed to furnish administrators with account numbers. Should this be the case, please contact the Comptroller's Office at extension 6401 and speak with Brother Richard Kyle, C.S.C., who will handle such omissions.

We believe the University's new accounting system will facilitate more timely and accurate reporting to all budget unit or fund administrators. The realization of this objective, however, requires that as an administrator you use faithfully and conscientiously the account numbers communicated herein.

This office will be available to assist any administrator with advice and clarification beyond that contained in this memorandum and its attachments.

Final Report, 1972 Commencement Program Committee

This is the final report of the 1972 Commencement Program Committee, appointed by the Provost last fall to study past commencement programs and to make recommendations for the 1972 commencement exercises. Helpful suggestions by Professors Goerner and Costello and close cooperation with the Senior Class Commencement Committee headed by Tom Pifferetti resulted in the Commencement Program Committee submitting to the Provost the following recommendations which he accepted:

1. Discontinue Class Day. Valedictorian to speak at commencement.
2. Discontinue awarding individual degrees to law students.
3. Senior class be permitted to arrange music for Baccalaureate Mass.
4. Faculty sit as a group with graduating seniors at Baccalaureate Mass.
5. A cocktail-dinner arrangement be available for seniors and their guests.
6. Picnic lunch boxes be available for Sunday noon meal for seniors and guests.
7. Department chairmen and faculty give out diplomas in North Dome of A.C.C. before commencement ceremonies begin. Purpose twofold: to personalize the reception of the degree and to eliminate the post-Commencement college distribution of diplomas.
8. Faculty of each department march ahead of their seniors in the commencement procession.
9. Senior awards be announced by the Provost at commencement.

With the submission of this report, the 1972 Commencement Program Committee disbands. However, it would like to acknowledge the excellent cooperation it received from Dean Corbaci, Dean of Administration, and Mr. Sullivan, Registrar. Hopefully, these changes contributed to making the 1972 commencement exercises a memorable experience for our graduates and their guests.
