Open Meeting for Faculty With North Central Accreditors

The 10-year accreditation visit by a team from the North Central Association will take place from Monday, February 21, 1994, to Wednesday, February 23, 1994. During the course of the visit, subgroups of the accreditation team will meet with various faculty, students and administrators of the University.

There will be an open meeting for any faculty who wish to attend on Tuesday, February 22, at 4:15 p.m. in room 210 of the Center for Continuing Education.

A meeting with students is scheduled for Monday, February 21, at 5:30 p.m. in the lecture room of the Center for Social Concerns.

The accreditation visit is being coordinated by Rev. Oliver F. Williams, C.S.C., associate provost (631-6858).

Contributions for 1993 Announced

The University raised a record \$60.9 million in cash contributions in fiscal year 1993, according to the annual report of the Department of Development.

The total, which does not take into account pledges of future gifts, exceeded by more than \$7 million the record established in 1990 and represented a \$13 million increase over 1992.

The receipt of several large gift payments from the "Strategic Moment" capital campaign (completed in 1990) played a significant role in Notre Dame's first year of more than \$60 million in cash gifts. Of this amount, cash raised through planned giving totaled \$2 million more than 1992, and record levels also were achieved in the Annual Fund and Sorin Society.

Planned gifts — including bequests, trusts, insurance and other estate gifts — amounted to almost \$8.2 million, and planned giving commitments totaled \$14.5 million. The Badin Guild, established for benefactors who include Notre Dame in their estates, now numbers 399 members whose anticipated gifts total more than \$110.7 million.

In its 50th year, the Annual Fund raised a record \$13 million, a 10 percent increase over 1992. The fund's matching gifts program also reached a new high of \$2.5 million. Among U.S. colleges and universities, Notre Dame is second only to Harvard University in both its number of matching gifts and total dollars raised through matching gifts.

The Sorin Society, the flagship of the Annual Fund, surpassed the \$6 million mark for the first time. The program includes contributors of a minimum of \$1,000 annually in unrestricted gifts, as well as Founders Circle members, who donate \$3,000 or more annually.

Foundation and corporate support to Notre Dame totaled \$18.7 million, the third highest total in the program's history.

Board of Trustees Executive Summary October 6, 1993

Three new trustees were introduced. Catherine A. David, a buyer with Target in Minneapolis, and Martin W. Rodgers, Washington, D.C., a legislative assistant to Sen. Harris Wofford of Pennsylvania, had been elected to the two positions reserved on the board for young graduates, and Paul J. Bonitabitbus, New Orleans, assumed an exofficio position on the board as president-elect of the Notre Dame Alumni Association. Two persons put forward by the board's Nominating Committee for trusteeship were approved by the Fellows of the University and the Trustees. They were Raymond G. Chambers, chairman of the board of the Amelior Foundation, Morristown, N.J., and Dr. Antonia C. Novello, former surgeon general of the United States, both honorary degree recipients of the University. Archbishop Marcos McGrath of Panama and Philip Faccenda, vice president and general counsel of the University, were elected life trustees.

Father Malloy and the chair of theology, Prof. Larry Cunningham, led an extended discussion of the apostolic constitution, *Ex corde Ecclesiae*, on the relationship of Catholic colleges and universities to the institutional Church. The trustees authorized Father Malloy to formulate, on the basis of input from appropriate University and Holy Cross groups, a response to the proposed ordinances for implementing the papal document in the United States.

Father Beauchamp briefed the trustees on the University's response to the book, *Under the Tarnished Dome*, which criticized the Notre Dame football program.

Judge Ann Williams reported on the work of the Social Values and Responsibilities Committee, particularly its role in cultural diversity initiatives at the University. A resolution, recommended by the committee and rescinding the board's policy of selective divestment in South Africa in the wake of the request of black leader Nelson Mandela for renewed investment in his country, was passed.

The board heard a report on the investment of Notre Dame's endowment from its committee in that area, and Father Beauchamp reviewed the 1992–93 operations budget.

Father Malloy and Provost O'Meara led a discussion of academic matters at the University in light of Colloquy recommendations.

Reinhold Niebuhr Award

Rev. Theodore M. Hesburgh, C.S.C., and Chancellor Willy Brandt of West Germany were the first recipients of Reinhold Niebuhr awards sponsored by friends of the Protestant theologian and author. Receiving this award in September 1972, at ceremonies at Union Theological Seminary in New York City, Father Hesburgh announced the establishment of a Reinhold Niebuhr award at the University of Notre Dame. This award is made annually to a student, faculty member or administrator whose life and writings promote or exemplify the area of social justice in modern life. The initial award to Father Hesburgh was \$5,000. This he turned over to the Notre Dame endowment to underwrite an annual cash award of \$250 for the winner of this campus honor. The selection committee includes representatives from the colleges and Law School, Campus Ministry, Center for Social Concerns, rectors. Ladies of Notre Dame and the student body. All members of the Notre Dame community are invited to submit recommendations for this award.

Grenville Clark Award

On October 20, 1978, Father Hesburgh was one of three recipients of the Grenville Clark Prize, an award given every three years by the Grenville Clark Fund at Dartmouth College. Following the procedure established when he won the Reinhold Niebuhr award in 1972, Father Hesburgh donated the \$5,000 Clark stipend to the Notre Dame endowment to underwrite a cash prize of \$250 to be awarded each year. This award is made to a faculty member, administrator or student whose voluntary activities serve to advance the cause of peace and human rights to which Grenville Clark devoted his extraordinary life of public service. 
