

Nominations are requested for the James A. Burns, CSC, Graduate School Award given annually to a faculty member for distinction in graduate teaching or other exemplary contributions to graduate education. Contributions can be in any or all of the following areas: building or developing a graduate program, teaching quality graduate courses, excellence as an adviser or thesis director, and excellence in service as a director of graduate studies or in any other similar position. Faculty from the colleges of Arts and Letters, Science and Engineering, and the School of Architecture, are eligible.

The nomination packet should include a minimum of four letters of support (two from students and two from faculty) but no more than six, and a copy of the nominee's CV. All documentation should be sent to the department chair, who will forward all

documentation to the Graduate School by Friday, March 10, 2006.

The first Notre Dame President with an advanced degree, a doctorate from the Catholic University of America, Father Burns was the leading reformer of Catholic education in this country in the first quarter of the 20th century. One of his most significant contributions was to raise academic standards by recruiting faculty with doctoral degrees.

Research Achievement Award

The Research Achievement Award is awarded annually to honor a distinguished Notre Dame faculty member who has made significant contributions to scholarship in his or her discipline and to the research and education goals of the University.

The deans of each of the colleges may nominate two full-time faculty members, currently active in research and teaching. In addition to a copy of the nominee's resumé, each nomination should include a two-page letter that addresses the selection criteria:

- Evidence of the nominee's commitment to his or her profession and efforts to further the University's research and scholarship mission.
- •The nominee's past research accomplishments and future research potential.
- •Demonstration of universal recognition as a research leader.

The vice president for Graduate Studies and Research will appoint a committee to review the nominations. The committee will include one member from each of the colleges and will make recommendations to the vice president for Graduate Studies and Research, who will select the winner.

The award will consist of a plaque and a \$10,000 award placed in a discretionary research account for the recipient's use. The winner will also be recognized in the Commencement program and at the President's faculty dinner.

Nominations must be received by the director, Office of Research, 511 Main Building, no later than March 10, 2006.

Reinhold Niebuhr Award Nominations Sought

Rev. Theodore M. Hesburgh, CSC, and Chancellor Willy Brandt of West Germany were the first recipients of Reinhold Niebuhr awards sponsored by friends of the Protestant theologian and author. Receiving this award in September 1972, at ceremonies at Union Theological Seminary in New York City, Father Hesburgh announced the establishment of a Reinhold Niebuhr Award at the University of Notre Dame. This award is made annually to a student, faculty member, or administrator whose life and writings promote or exemplify the area of social justice in modern life.

The initial award to Father Hesburgh was \$5,000. This he turned over to the Notre Dame endowment to underwrite an annual cash award of \$250 for the winner of this campus honor. The selection committee includes representatives from the colleges and the Law School, Campus Ministry, Center for Social Concerns, rectors, Ladies of Notre Dame, and the student body. All members of the Notre Dame community are invited to submit recommendations for this award to Joy Vann-Hamilton, assistant provost, 300 Main Building, prior to March 10, 2006.

University Committee on Women Faculty and Students

University of Notre Dame Meeting of November 8, 2005

Prof. Blum, chair of the University Committee on Women Faculty and Students, called the meeting to order at 11:05 a.m.

- 1. Minutes of the meeting of 2005: Prof. Blum decided that the minutes of the meeting of October 10, 2005 (revised slightly since the first mailing), would be sent to all members again and approved by e-mail vote. [One member submitted slight changes in wording after the second round; the minutes were otherwise approved.]
- 2. Election of a chair-elect/discussion of requirements for chair: In order to maintain continuity from one year to the next, members decided at the last meeting to elect a chair-elect for the Committee.

Prof. Blum first noted that the Academic Articles require that a tenured woman member hold the position of chair; that woman, however, need not be an elected member.

Prof. Bellia said that while she would be willing to serve as chair, she has a zero teaching load this coming spring term and may not teach in the fall 2006 term.

Prof. Bergen, who was not able to be present today, had informed members at an earlier meeting that she will be on leave for the Spring 2006 semester.

By written ballot, Prof. Bergen was elected chair-elect of the Committee.

Members noted that because the minutes of the meetings are so complete, Prof. Bergen's Spring 2006 leave will not be detrimental in her assuming the chairship when she returns in the Fall of 2006.

Members then discussed whether they should propose a change to the Academic Articles—particularly one that would allow library or special professional faculty to serve as chair. One member observed that a chair who is a member of the teaching-andresearch faculty carries greater credibility within the University than does a person who is a member of the library or special professional faculty; she can thus be a more effective voice for the Committee. Other members questioned that assumption.

Addressing a different facet of the issue, Prof. Linney commented that when the Committee was first founded, it was perhaps true that only a tenured woman could take the risk of serving as chair. Now, however, the climate at the University may very well have changed.

Members concluded that they would consult with Prof. Teresa Godwin Phelps, who has served as a member and chair of the Committee at various times throughout the years, for her view on this question.

3. Committee reports:

(a) Infant care: Prof. Linney summarized the report she made at the last meeting concerning infant care: The campus Early Childhood Development Center would require an extensive addition to enable it to offer infant care along with its current services for children age two through kindergarten. Also, requirements for infant care pertaining to the ratio of full-time care providers to infants—as well as the advanced degrees the providers hold—are such that, even with Notre Dame's institutional subsidy, costs to parents would run about \$200/week.

One member said that when taking account of time lost traveling between campus and one's private daycare provider, that amount could be well worth the expense.

Sr. Gude said that interest in on-campus daycare for infants will be a part of the upcoming survey of graduate student life.

Ms. Redfield said that having an oncampus childcare facility buttresses the status of women at Notre Dame. She noted that work/family issues are important to students; in fact, the student organization Feminist Voice has a standing committee on this topic.

Members were unanimous in recommending that the Committee continue to pursue the availability of infant daycare for the University community. The first step is gathering information on demand for that service.

(b) Web site: Ms. D'Aoust reported that she has looked at Web sites of women's committees and groups at other universities—including Yale, Northwestern, and North Carolina State—and plans to look at several more. In her survey, she is keying in on whether an institution's Web site seems to be primarily for the women of that community or whether it is intended to project an image to the outside world. To gather input both on design and the kinds of information that can be organized within a Web site, she will present different

examples of Web sites to the Committee at the next meeting.

(c) **Health issues**: Prof. Blum first noted that some of the work of the subcommittee is on hold because of the birth of Prof. McDowell's baby. Prof. Bellia reported that one area the subcommittee is focusing on is helping to smooth procedures for women who, for medical reasons, seek a waiver of the University's policy that the costs of contraception cannot be covered by health insurance or flex spending.

Ms. Redfield said that a focus on the health front for student members is adding a gynecologist to the staff of University Health Services.

Prof. Blum reiterated the willingness of the Committee to write a letter to the administration when the students' proposal is complete.

- (d) **Graduate student retention**: Prof. Saddawi presented various statistics on graduate student retention within the College of Engineering.
- 4. **Status of Gender Studies Program**: A member raised a concern over the status of the University's Gender Studies Program. That concern extends to what seems to be shrinking resources for the program as well as its leadership. The current director has already extended her term by one year, and there is a very small pool of available candidates in Arts and Letters to replace her.

Prof. Blum noted that while the pool of potential program directors is quite small, Gender Studies is a strong program with classes that are very interesting to students. It meets a critical need at Notre Dame.

There being no further business, Prof. Blum adjourned the meeting at 12:30 p.m. Respectfully submitted,


